SUBJECT: **Regulation Update**

PERSONAL SERVICE PERMIT

(Title 16, CCR Section 965.2 (Personal Service Permit))

This regulation package required a 15-Day Comment Period. The comment period ended on July 14, 2020. The Board received two public comments. The comment responses are being submitted to the Board for approval.

Action Needed: In order to continue the regulatory process of the Personal Service Permit regulation package, board staff needs a motion to direct staff to reject the comments, provide the responses to the comments as indicated in the meeting materials, and complete the regulatory process.

Summary of, and Responses to, Comments Received During the 15-day Comment Period on the Modified Text and Data Added to File

The following 2 individuals submitted written comments to the Board on the proposed rulemaking during the 15-day comment period:

- Anne Fisher (Fisher), Director of Spa-Go's
- Randa Thurman (Thurman), electrologist and owner of Monterey Bay Institute of Electrology

Comment from Anne Fisher: Fisher stated to pass the PSP now and allow workers to serve clientele in guest homes to limit the exposure to the client and the worker. She also believes the Board should not charge for this permit this year or next year due to salon closures and their inability to keep affording new standards of care, equipment, masks, sanitation and this additional permit.

Response: The Board rejects this comment. Fisher's suggestion to pass the regulation now is not relevant to the modified text and data added to file. As for the suggestion to waive the permit fee, it would not be practicable for the Board to waive the fee. The Board needs the fees set in the language in order to support the costs of processing applications, printing permits, and mailing permits for both initial and renewal applications. The Board makes no substantive changes to the language.

Comment from Randa Thurman: Thurman suggests that the Board should expand the regulation to include electrolysis services so electrologists can visit retirement homes. The proposal should give electrologists the same opportunity as the barbers, cosmetologists, estheticians, and manicurists.

Response: The Board rejects this comment. Electrologists are not included in the Personal Service Permit regulation because electrology is an invasive procedure and should be conducted in a controlled environment to reduce the risk of infection. Providing this service outside of a licensed establishment would increase the risk of consumer harm. The Board makes no substantive changes to the language.






7. Click the audio menu below the green 'Join Event' button.

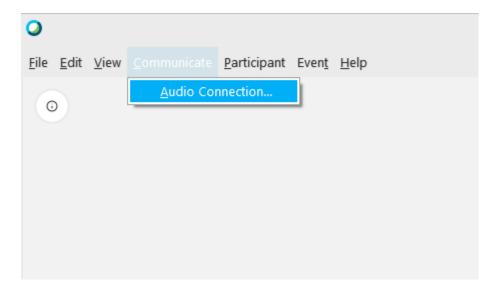

At certain times during the event, the facilitator may call for public comment. If you would like to make a public comment, click on the 'Q and A' button near the bottom, center of your WebEx session.




This will bring up the 'Q and A' chat box.
